PURPOSE

Under subsection 47(1) of the TCPSS Act, the Australian Communications and Media Authority (the **ACMA**) must make a written assessment of each participating person's eligible revenue for an eligible revenue period (other than the first eligible revenue period).

ASSESSMENT OF ELIGIBLE REVENUE OF PARTICIPATING PERSONS

The ACMA's assessment of each participating person's eligible revenue for the 2018-19 eligible revenue period is as set out in Table 1, such that for each row in the table:

- Column (1) specifies the name and where applicable, the Australian Company Number (ACN) of the participating person; and
- Column (2) specifies the assessment of eligible revenue for each participating person named in Column (1), in relation to the 2018-19 eligible revenue period.
