Many thanks again for confirming your participation as speakers at the Regional Regulators' Forum (RRF) on 8th February which kick-starts our annual Asia Telecom & Media Forum. It is a pity we can't all meet over coffee next month, but hopefully we will at some point this year!

I am delighted that Andrea Millwood Hargrave will be moderating the opening panel – Andrea was Director General of the IIC until 2020 and I know she is very much looking forward to 'seeing' you all on her screen soon. The RRF comprises 3 panels – the first of which focuses on protecting citizens and consumers. Details can be elaborated on during the discussion which will follow - Andrea will initiate this with questions which will be agreed in the prep call. We do not require slides – however if you would like to use one or two to help illustrate specific points or data then please let me know.
