Dear friends and colleagues

It was a pleasure to speak with you all earlier this week – thank you for making the time for us to e-meet.

As we know, you form the opening session of the Regulators' Forum and the issue, Protecting consumers and citizens, is key, along with supporting industry, to a regulator's role. The various initiatives your organisations have put in place, especially at this time of continuing global disruption (not only in the technology sectors), will be of significant interest to your colleagues and I am honoured to be your moderator.

I would like to suggest the following running order, bearing in mind you have been allotted a (strict) 5-7 minutes:

- **Myanmar:** Aung will speak briefly to the challenges Myanmar has faced since the sector has opened up (almost ten years ago) and the initiatives that have been put in place, heightened by the pandemic.
- **Taiwan:** Wei-Chung will speak to initiatives put in place not just for the pandemic but also the public warning systems to deal with disasters such as earthquakes.
- **Australia:** Nerida will follow on by describing what regulatory measures have been in place (such as regulatory forbearance) since the pandemic to support industry as well as consumers/citizens. She will move on, I hope, to talk of some of the areas beyond the pandemic such as the key codes and acts that are going through in Australia or have been put in place recently – and their reasons. Crucially I hope she will touch on the important issues of cooperation and collaboration,

nationally and internationally.

That should allow us to move to key current issues, time permitting, such as (not an exhaustive list):

- Cooperation and collaboration - why it is important
- Ensuring equality of information, especially with large non-urban populations
 - Access issues
 - Combatting disinformation
- Ensuring an understanding of the issues, exacerbated by the pandemic:
 - Spam
 - Nuisance calls
 - Protecting personal information (identity theft was mentioned)
 - Cybersecurity
 - Media/digital literacy

If you feel I have left anything out or you disagree with the order please do let me know.
