I find it even more disturbing if it's my own government (via [@eSafetyOffice](#), [@acmadotgov](#) or otherwise) rather than just Big Tech that's censoring me.

And that's why [@AlboMP](#)'s [@AustralianLabor](#)'s 'Misinformation Bill' (aka Censorship Bill) is so terrifying.

We already have heavy-handed censorship online, imagine how much worse it's going to get under this legislation?
